Example 1. New application for categories 2 & 3:

New Category 2 Application fee of 578.50 plus Cat 3 fee of £117 = total fee payable £695.50.

Example 2. New application for categories 1, 2 & 3

New application fee of Cat 1 £812 plus Licence Cat 2 fee of £185 plus Licence Cat 3 fee of £117 = £1114.

All licences expire 31st October each year.

New licence fees are pro rata to a minimum of 6 months and a maximum of 18 months.

Example 3: New application received in May - Fee would be $^{6/12}$ of total fee.
