#### **Foreword**

Redbridge is a diverse and thriving borough. The choices people make about how they travel have critical impacts on their health, safety and wellbeing. The decision about whether to take the bus, train, cycle, walk or using the car are defined by the transport opportunities available. These transport choices also have wider impacts on the economy, the environment, air pollution and wider climate.

This strategy is designed to ensure that our residents, businesses and visitors have a transport system that serves their needs, now and into the future. This strategic approach looks at all the elements that make up our transport system, the principles that underpin it and sets out a plan to keep Redbridge moving. This document will guide our choices about where we invest, what we lobby other agencies for, how we cooperate across the Council and across borough boundaries. It aims to make our streets safer, vibrant, healthy, attractive and good for business.

Through this Strategy we will create a fairer transport system to keep Redbridge moving, that is fit for the future and enables everyone - young and old, people of all races, genders and walks of life, to all travel safely, independently and efficiently.

#### What is the Strategy?

- The Borough's first Sustainable Transport Strategy with an ambitious vision
- \* The Strategy is evidence based, policy led and reflects the needs and wants of local communities in Redbridge.
- \* The document sets out a clear plan and targets to keep Redbridge moving, with a focus on safer, more accessible, and greener travel.
- \* The Strategy recommends the actions that we and our partners will need to take to achieve the vision.







#### What are the timescales?

- Our goals and actions fit with the London-wide Mayor's Transport Strategy timeline for 2041.
- This provides a long period of time during which policies and transport infrastructure can change and improve. We will deliver key targets over the short, medium and longer term.



#### We have developed this strategy together with our communities

- \* The Strategy has been designed with the support of various groups of people in Redbridge, including:
  - younger people and schools,
  - elderly people,
  - disability groups,
  - transport stakeholders,
  - and other community groups.



- Engagement with these groups has helped to identify four key themes and nine priorities for the Strategy.
- The challenges and opportunities raised during engagement have helped to inform a range of actions and interventions for the Council and key partners to deliver.



## Why do we need a Strategy now?

- \* Redbridge does not have a dedicated, long-term plan for how transport will develop across the borough.
- Climate and public health emergencies have highlighted the need for intervention
- If we do not act to make changes to the transport network in the coming years, Redbridge may face new transport problems, and some existing issues are likely to get worse.

#### **Our Vision**

This Strategy sets out a clear **vision statement** of where the Borough needs to be by 2041, to keep Redbridge moving:

- By 2041, Travel in Redbridge will be safer, healthier, greener and more inclusive.
- \* There will be more affordable choices for all journeys that help us to live healthier and more independent lives.
- \* At least two thirds of all journeys will be by public transport, walking, wheeling, cycling or scooting.
- Ambition to create safe and seamless connections between the bus, Underground and rail networks.
- Deliver an extensive network of zero-emission vehicle charging points in Redbridge.



## **Key themes and priorities**

- \* To deliver on our Vision, we have created four key themes and nine priorities, each related to a topic or issue that the Strategy will address.
- \* All our priorities are interconnected. By working towards one priority, we will be helping to achieve the others.

#### How are these used in the Strategy?

- For each priority area, we have undertaken an assessment of existing evidence and identified issues and opportunities. These inform what actions the Council will take on each priority and why.
- Individual actions may address more than one priority at a time, so our action plans sit under the four key themes, bringing actions on similar issues together.

#### Theme 1: Active and safer travel for healthier lifestyles


Which priorities are important here?

- Improving road safety and air quality
- Enabling healthy lifestyles
- Enabling active travel
- Education, promotion and engagement

- Engage with residents on new road safety schemes
- Implement road safety zones to calm traffic, expand safe crossing points and increase pedestrian safety
- Complete the school streets programme to keep children safe walking, cycling and scooting
- Continue progress to install 1,000 electric vehicle chargepoints in the Borough by 2026 and more in future years
- Improve provision of cycle networks as part of the sustainable neighbourhoods programme
- Work with key partners to influence speeding and driver behaviours

#### Targets

#### Theme 2: Making transport and travel accessible


Which priorities are important here?

Increasing accessibility and creating high quality public realm

- Work with TfL and local communities to improve bus priority in the Borough and make bus stops accessible
- Lobby TfL to introduce lifts at Wanstead, Redbridge, Gants Hill, Barkingside, Fairlop and Snaresbrook
   Underground stations
- Improve the public realm by de-cluttering streets
- Encourage groups of children walking to school with one or more adults
- Develop a programme for footway renewals
- Improve signage and develop accessible walking maps

Reduce the number of stations without step-free access



# Theme 3: Enhancing the environment and responding to the climate emergency


Which priorities are important here?

- **Enhancing the environment and biodiversity**
- \* Responding to the climate emergency

- Improve biodiversity within the public realm, introduce community planting
- Manage biodiversity during construction of new developments and infrastructure
- Reduce the negative impact of heavy traffic, vehicle emissions and noise on the environment
- Ensure urban drainage is managed sustainably to reduce flooding
- Plant new trees and sustainable drainage as part of new road safety, cycling schemes and improvement works



#### Key proposals across the Borough



#### **Targets**

Ensure new transport and infrastructure supports sustainable urban drainage

Ensure new transport and infrastructure supports a net increase in biodiversity

Plant new trees with new cycle routes

Increase number of public EV charge points

Reduce CO<sub>2</sub> and NO<sub>x</sub> emissions



#### Theme 4: Keeping Redbridge's economy moving


Which priorities are important here?

- Supporting housing, jobs and economic growth
- Rethinking freight and servicing

- Ensure new developments include sufficient cycle parking and electric vehicle charging infrastructure
- Ensure new developments promote sustainable travel through travel plans
- Work with TfL and other boroughs to manage congestion on roads
- Ensure the Council's vehicles meet national safety standards
- Liaise with transport and logistics organisations to meet national safety standards



#### Key proposals across the Borough



#### **Key targets**

Increase the share of zero emission Council vehicles

Council vehicles to be FORCS or CLOCS accredited

Collect collision data

Increase parking for powered two wheelers

Trial a last mile delivery hub by sustainable modes

Identify and improve key accident locations for delivery vehicles



#### **Next steps**

We will be consulting on our first draft Sustainable Transport Strategy as part of the Council's wider, ambitious plans for a healthier, safer and cleaner Borough.

The consultation is open for 12 weeks from 1 October until 24 December 2024 and we are encouraging everyone to respond to help shape the future of transport in Redbridge.
