The period of consultation has ended. This is a notification that this tree is proposed to be removed 28 days from the date of this notice. This decision notice meets the duty to consult and notify when removing street trees set out in section 115 of the Environment Act 2021

Summary of responses We received 1 objection requesting further information as to why the tree needs to be removed and is unable to be maintained with pruning works.

Decision summary Tree's growth habit is causing the tree to lean over the road and the tree has lost its central leader. This location is suitable for a large upright tree and due to the tree's lean and loss of leader we will have to maintain the tree in a reduced form to keep the road free from obstruction. Therefore the tree will be removed and replaced.

Solutions considered Pruning is not considered a suitable solution, due to the tree's ultimate size, speed of growth and will not reform an acceptable crown shape. The tree is too mature to be transplanted straight with out causing significant damage to the root structure.

Replacement A single replacement tree, suitable for this position, is programmed to be planted between November 2024 and March 2025
